Current employees grandfathered longevity is applied at years of service for current members in a confidential position. Effective 11/12/15 any new hires to a confidential position longevity will be granted based on time served in a confidential position.

The longevity steps shall provide a 3% increase after completion of three (3) consecutive years of service in a confidential position; another 3% increase after completion of six (6) consecutive years of service in a confidential position; another 3% increase after completion of nine (9) consecutive years of service in a confidential position; and another 3% increase after completion of twelve (12) consecutive years of service in a confidential position.

1.5% Increase Effective 7/1/21 (Board Approved 6/24/21)

1.75% Increase Effective 7/1/20 (Board Approved 6/24/21)

2.43% Increase Effective 7/1/19 (Board Approved 9/26/19)
