REGULAR BOARD MEETING January 14, 2021 Public Comments

I am a resident of the Spring Lake community and want to express my objection for the use of Spring Lake builder fees to rent/pay for temporary facilities as the builder fees were intended for the use of BUILDING schools in this area. If such temporary facilities are needed, I propose alternative funds be used. Funds provided through the builder fees are not limitless; and therefore, I would hope these funds are used wisely, effectively, and efficiently for what it was intended for - BUILDING of schools first.

This concern/object comes from my limited understanding that funds from the builder fees seemed to have been wastefully used - with funds for the MPR building project available on June 30,2018, construction didn't take place until December 2019. For this reason, portables were required, which cost a large amount of money and thus charged to the local Spring Lake CFF (funded by builder fees) - funds that could have gone into permanent school building projects.

I hope WJUSD would consider your vision statement: "Excellence in Facilities and Operations" so that your mission statement - "prepare and empower all students for a future of endless possibilities" can be achieved without limited funds running out.

I strenuously object to using builder fees for temporary rooms. I am very disappointed/angry that Spring Lake school is still not built out. Please, please, I urge you to proceed at WARP SPEED! Do not waste time, money, or energy on anything temporary. If it's worth doing, it's worth doing right the first time. Get this done!!

I would like an explanation as to why we have deviated from the school's initial plan, and I would like documents and assurances that there will be enough funds to complete the school as was originally planned and on a schedule that resembles what is possible and what was promised.

Greetings Superintendent Pritchard, President Whitaker and Board of Trustees,

It is great that the district is investing in the development of a facility master plan. I had a few questions that I was hoping the district and LPC Inc., the company selected to perform the work, could address during the board meeting tonight. LPA Inc. included community and townhall events in their proposed schedule. How do they plan to reach out to the community to ensure it is representative of our whole district? What type of impact do they see the community having on their facility master plan?

The scope of services from LPA Inc. outlined in the proposal does not include assessing the need and prioritization of future schools. We have an established need from the most recent justification study for another elementary school to meet the needs of future students. The school fee and justification study which was presented to the board on April 6, 2020 identified a need to accommodate for the addition of 706 projected elementary students from future construction in Woodland. These numbers do not account for the Tech Park which could add an additional 400 elementary students. Spring Lake elementary needed to turn away students this year and has a waiting list of 20 students which even includes students with siblings currently attending the school. The number of students turned away will only increase each year as the community grows. The study identified 276 surplus seats in elementary schools across the district but that still leaves 430 projected unhoused students. Unless we start planning for this growth now, hundreds of families that purchase homes in the Spring Lake area will be turned away from attending a school which they help pay for with their builder fees.

Have you considered this need? What is your plan to address this need and could this be included in the scope of services for a development of a facilities master plan?

Spring Lake Elementary - Builder Fees for Buildings not Rentals

Background:

Spring Lake Elementary School is being constructed in phases.

Phase 1: TK-4 grade classrooms (completed).

Phase 2: multi-purpose room.

Phase 3: 5-6 grade classrooms.

Phase 4: playfields.

As the TK-4 classrooms were completed in 2018, community members had been reaching out to the WJUSD and the School Board highlighting the importance of constructing the multi-purpose room (MPR) as soon as possible. Expedient construction of the MPR was vital to avoid the use of portables, wasteful spending, and for our students to finish their elementary education at Spring Lake Elementary on a completed school campus. Despite the District and Board's awareness of the necessary timeline, and the funding for the MPR being available on June 30, 2018, no action to initiate construction of the MPR was taken until December of 2019. This 18-month delay resulted in WJUSD needing to bring in a portable/temporary MPR at the cost of \$300,000. This cost was charged to our local Spring Lake Capital Facility Fund (CFF) which is funded by developer fees, is limited, and is intended to be used to BUILD schools in Spring Lake.

Cause for action:

At the upcoming January 14, 2021 WJUSD school board meeting, there will be a discussion regarding funding sources for the erection of additional portable/temporary structures for phase 3, the 5th and 6th-grade classrooms for the 2021-2022 school year.

Action:

We are looking for community support to oppose using Spring Lake builder fees to pay for these portables, and instead pay for them from an alternative funding source. Spring Lake CFF builder fees should be used for the completion of the Spring Lake Campus, not for temporary structures necessitated by unnecessary delays. Please support our petition to oppose using Spring Lake CFF Builder fees to pay for portables at Spring Lake Elementary.

Please consider submitting a voicemail recording or email in <u>public comment</u> for the school board meeting on 1/14/21 to help protect funding for the completion of our school and opposing the use of Spring Lake CFF funds for portables.
