Dear Board Members -

Neighborhood schools with reasonable classroom sizes are the lifeblood of a thriving community. They bring together parents and children, they improve property values, and create positive outcomes for children because of the proximity to the school and attention from teachers.

When I moved to Spring Lake, I was under the assumption that schools would be built to educate the massive growth happening in the southeast corner of Woodland. In fact, when you look at the area from an airplane approach Sacramento International Airport, the area south of Gibson Rd. looks like it will be roughly 1/3 the total area of Woodland by time all is said and done. We have beautiful parks and thriving young families. What we do not have, is a neighborhood school to accommodate the nearly 1000 children who are anticipated to be of school age in the coming years. I grew up a public school kid, and would love my 1 year old daughter to experience the diversity and education of a public school. However, I may have no choice if I have to drive her miles away to go to her "local school," Tafoya, which really is not local at all and will be dramatically overcrowded.

The goal of any school board should be to provide the best education possible for each and every student. Unfortunately, an overcrowded school where kids are driven or bussed in from miles away does not provide the best education possible. A new neighborhood school to accompany the new growth and tax base the city is seeing would be, giving each child the attention they need to succeed.

The time to act is now. The past is the past, but all could be forgiven if you take the first step in acquiring land at the Tech Park in order to build this school. The demand is there, the tax revenue is there, but the school is not.

Hello,

I have lived in Springlake since 2010. When I bought the house it was clear to me in the Springlake master plan that multiple schools would be built to serve Springlake residents. The developer fees were evidently supposed to fund these, but it has become clear that the efforts by the school board and the city have been magnificently mismanaged. It is appalling that so many elementary students have to be driven to schools on the other side of Woodland as the Springlake school is not adequate. Now the city is on the cusp of approving a new development (Tech Park) which needs to include adequate funding for local schools.

I am asking the city and the school board to have a spine and negotiate with the tech park developers and not give us, the people affected by your decisions, the run around. It is your chance to redeem previous inadequate efforts. Fix your broken promises to those of us who feel betrayed. Betrayal fuels resentment and that isn't good for anybody. You can't continue to make decisions on important issues that affect us without our input.

Note that there are many residents in Springlake seething with anger and this issue is never going

to go away until the city and board step up to fulfill promises made to many of us when we moved here. Also note that any "developer fees" associated with residential construction are actually paid by US, the homeowners who shelled out good money for our homes. So we are asking you to be responsible for OUR money as you proceed with your tech park negotiations. Take a hard look at the long run and not putting little band-aids on past bad decisions (like choking the roads with parents driving their kids to school across town). This is no way to create a thriving community. The school district is already loosing funding by Springlake parents who are fed up and finding other out-of-district schooling for their kids. Where is your vision??

Your developer "negotiations" may be closed doors but we will find out what you've done one way or another. And the community will know about it.

I would like to encourage the School Board to consider the whole of the Spring Lake area, including the proposed research park, as a unified area of need for elementary and junior high schools. Before more housing is added to the area it would seem prudent to be sure that educational needs of all of the residents, current and future, are met. As it stands now the residents of Spring Lake have one expanding elementary school and yet residents of that area cannot be guaranteed that their elementary aged children can attend that school. Moreover, attendance by one child at Spring Lake Elementary does not guarantee that siblings can also attend that school. This is a ridiculous situation and sends more WJUSD students into private schools or to Davis schools.

My children both attended Whitehead elementary and Lee Junior High which were both in our neighborhood. It would have made our lives much more chaotic had they been at different elementary schools or in schools across town.

Please make elementary and a future junior high school, neighborhood schools which can be used by the residents of Springlake and a future research park housing area.

I am writing to support the inclusion of a school site in the proposed Woodland Tech Park.

Spring Lake residents were promised access to neighborhood schools in the Master Plan. Now homes sit on two of the originally proposed neighborhood school sites. Spring Lake Elementary had 42 kids on the kindergarten wait list this year. MANY of our neighborhood kids lost the opportunity to attend a school that they can walk or bike to due to lack of foresight and inclusion of adequate seats in a neighborhood school.

With the planning of the Tech park and housing that goes along with it, there MUST be a neighborhood school included in the plan. This is not only good for our kids and our community, it is good for the developer. We want this project to be successful, and this project will be much more attractive to businesses if future employees can access local housing and schools for their kids.

We have heard many arguments and excuses from the City and District against including a school in Spring Lake. None hold water, and are quite frankly, lame.

We have heard that enrollment in WJUSD is declining. While that may be true district-wide, it is NOT true in Spring Lake where all of the growth is--and the houses keep going up and the families keep moving in. There was a significant wait list at Spring Lake Elementary this year, and according to the district's own student generation numbers, when Spring Lake is completed and the tech park finished, there will be close to 1000 elementary aged kids without a neighborhood school. Yes, district enrollment will certainly go down if we don't give them seats at a neighborhood school--

they will leave the district, or move to private school options!

We have heard that existing schools can't be closed because it is too hard and politically unpopular, but many of our existing schools are old and crumbling. Yes, closing an existing school is politically hard and unpopular, but let's talk about EQUITABLE access to neighborhood schools. There are NINE elementary schools on the other side of Hwy 113, and TWO on this side, where all of the population growth and development is happening. Spring Lake master plan included at least three new elementary schools when I bought my first house here in 2008. We were lucky to get a spot at Spring lake for our first child, but there is a good chance that there won't be room in a neighborhood school for our second. Including another school in the Tech Park, is an opportunity to provide more equitable access to a neighborhood school (that we were promised) for Spring Lake residents, and will be a draw for businesses looking to set up shop in the tech park--what a selling point--come to work, live down the street, and drop your kid off on the way!

Planning for our kids' and our community's future by ensuring equitable access to neighborhood schools, decreasing the environmental impact of commuting across town to deposit kids at a distant school site, making locating a business in the tech park more alluring by providing amenities such as a neighborhood school, and delivering on the promise Woodland made in its master plan, and that we were promised when we bought homes here are the right thing to do, and good for our community, kids, developers, and all of Woodland.

Please do the right thing and include a neighborhood school in the Tech Park.
