Pursuant to Government Code section 54953, subdivision (c)(3), the Governing Board provides this oral summary of the salary and/or fringe benefits for the executive position of Superintendent to be filled by Ms. Elodia Ortega-Lampkin. The term of this Agreement shall be effective as of March 1, 2022 for a four-year term. The annual salary to be paid is \$260,000.00, less all statutory and other deductions. The Agreement also provides for the same health and welfare benefits as other District certificated management employees, 24 days of paid vacation, a monthly automobile allowance of \$300, payment of professional dues, and use of District-paid technology devices including a cell phone and laptop computer.
