A. CALL TO ORDER IN OPEN SESSION - 5:00 P.M.

C. PUBLIC COMMENT FOR ITEMS ON SPECIAL BOARD MEETING AGENDA (Please fill out the Public Participation Form) Members of the public are encouraged to attend Board meetings and to address the Board concerning any item on the Special Board Meeting Agenda. Individual speakers shall be allowed three minutes each to address the Board on Special Board Meeting Agenda items. The Board shall limit the total time for public input on each item to 20 minutes. This is a comment period only, and the law does not allow the Board of Trustees to take action on any item not explicitly posted on the agenda in advance. Katie Hunter shared concerns about the bond funds not being used for the stadium projects despite the communities support for those projects. She felt that the community may be less likely to pass a future bond if the funds are not spent in a way that reflects the voices of the community.

Eric Garber and Jennifer Owens felt that a strategic plan for facilities was needed to make decisions, as well as demographic data (via voicemail).

Brian Coward expressed concerns about CTE flagship projects, security and safety needs being more critical than stadium projects, the lack of sun shelter at Spring Lake ES, and the need for a long-term strategic plan for facilities (via voicemail).

Public Comments Submitted Via Email

Dear Superintendent Ortega-Lampkin, President Whitaker, and Board members,

My name is Brian Coward. I'm a Woodland resident writing in regard to item 'D.1.Information/Action: Review the Draft Facilities Master Plan (FMP)'. It's great to see this item on the agenda! It's critical that Woodland schools be safe, well maintained, and show that the District cares about the environment our children, teachers, and District staff learn and work. I have questions and concerns about the LPA presentation tonight and the FMP overall.

There's mention of a "Flagship CTE project" for the high schools. What is this referring to? On pages 8 and 9 of the presentation, there's a reference to a "Woodland HS Stadium" and "Pioneer HS Gym & Fields" for

\$13,512,000 and \$11,145,000 respectively. I assume these are the flagship projects. I would strongly oppose any improvements to athletic facilities until all the immediate and security & accessibility needs of the schools are met. The safety of the campus and the environment in the classrooms are far more critical to our students learning the skills necessary to succeed in life than the athletic trophy of the glory days.

The "After Ratings Adjustment" spreadsheet on page 10 prioritizes improvements through a "Level" system 1-3 with 1 being the highest priority. Level 1, at the moment, includes immediate needs, classroom modernization, and lunch shelters (select sites). I believe we're making two mistakes here; security and accessibility should be addressed prior to classroom modernization or shelter, and the lunch shelters appear to leave out Spring Lake Elementary. There is great concern in the community about the safety and security of our campuses and we have an opportunity now to address these needs which would provide peace of mind to parents, students, teachers, and staff alike. Obviously, shade and shelter from the elements is a high priority for campuses since those improvements are itemized out. Spring Lake Elementary deserves to be provided the same level of attention and resources to eat and play outside. The current shade structure at SLE shades the bike rack. It will not provide shade for children eating lunch.

Also, we should take into consideration the long-term strategic plan of the District and improvements to facilities. Why would the District waste money on classroom modernization at Douglas MS when that campus is going to be relocated to the District property south of Pioneer HS? Why would we waste money on classroom modernization at Gibson ES when we can build a new school, with state matching funds, in the Tech Park? All of that to say the District did not, as it suggested the FMP update would, provide a 5-10 year strategic plan to meet the needs of Woodland as it continues to grow. Without a strategic plan we could be wasting money on improving facilities that need to be relocated and missing out on opportunities to build modern schools with state matching funds. When will a strategic plan be provided by the District?

Finally, where can we access the finalized FMP Documents, especially the Funding Analysis/Financial Plan?

My name is Brian Coward. I'm a Woodland resident writing in regard to item 'E.1.a. Property: Land Acquisition for Potential Elementary School in the Woodland Research and Technology Park (WRTP) as Specified in the WRTP Specific Plan,'. It's great to see this item on the agenda! I've provided an email with a copy of a financing letter submitted through the District's public comment email and I'd like to present additional options the District may consider in order to finance new schools and maintain existing ones.

Woodland is continuing to grow. The City is approving plans for Ruby Estates (88 single-family lots), Prudler Subdivision (183 single-family units), Spring Lake Central (375 single-family lots), Pioneer Village/Casera Meadows, and Cannon Pointe (231 single-family units), and Beeghly Ranch (72 singlefamily lots). This might not include all of the existing developments currently underway. That's an additional 949 single-family units that will bring in families that will need access to neighborhood schools. The District should closely monitor the incoming fees for Fund 28 to provide an indication of how quickly Spring Lake is growing and the expected impacts of enrollment at Spring Lake Elementary.

I would also like to suggest the use of School Facility Improvement Districts (SFID) be implemented by the District to fund school maintenance and new schools across the District. SFID's can be established for sub-areas within the District, can serve communities at a micro-local level, and only require a supermajority (55%) of voter approval within the district boundary being formed. An example would be 'Dingle Elementary School SFID' with a boundary the same as the homes assigned to that school. The District would provide the Facility Master Plan for Dingle ES as a bond measure, requiring 55% voter approval, for the homes assigned to that school. An SFID would supplement the existing resources for facility needs which are woefully insufficient. This is apparent in the current FMP update that shows, District-wide, half a billion dollars in facility needs.

I would also like to interject the possibility of financing new schools and maintaining old ones through donations. The District could make an effort to identify specific project needs for schools, the cost for those projects, and perhaps a matching fund for every dollar donated. This would give those donating a specific project of interest and incentives for their donations by the District also promising to match their donation for the project. Donations have been successful for the City of Woodland in developing its parks and in Davis with the Healthy Davis Together program.
