## **Public Comments Submitted Via Email**

Hello.

I'm submitting my written public comment for the meeting minutes and I've left a voicemail recording to be played during general public comment at tonight's Board meeting.

Hello Superintendent Ortega-Lampkin, President Villagrana, and Board Members,

My name is Brian Coward. I'm a father, husband, Woodland resident, and member of the Woodland Accountability Community group. I am here once again to bring to the attention of my District and Board of Trustees the terrible inequity being placed upon Woodlanders and the sum 880 Spring Lake children that do not have access to a neighborhood school. This District made an agreement with Woodland residents and the Spring Lake developers (Turn Of the Century, TOC) to provide two schools, each with a capacity of 650 students, and for a fee that every resident paid of, on average, \$16,000. Spring Lake is nearly complete. We have a single school, Spring Lake Elementary, with an anemic student capacity of 420.

Item N. Information: Requests for Future Agenda Items includes a 'TBD: Potential Expansion of Spring Lake Elementary School (Requested through Board action)'. Trustee Rodriguez, you initiated this

request at the last board meeting. I believe you meant well but as you're aware the District and the Board worked on such an effort in October, 2021 and it failed due to overwhelming public disapproval. There are challenges with the existing multipurpose room, student center, blacktop areas, security, and traffic safety that were not designed to accommodate a larger campus or more students. Expanding the Spring Lake Elementary campus is not the best use of our resources and will result in fewer students having access to neighborhood schools.

Trustee Rodriguez, please request this item be removed from the future agenda items list and follow that request up with one to discuss amending the Districtwide Facilities Assessement (DFA) to include a new elementary school in the Research and Technology Park. We need the DFA amended as soon as possible as the City is finalizing plans for development to begin and which when complete will add 4,000 additional Woodlanders. Amending the DFA is the first step in making sure we're able to plan, finance, purchase land, coordinate with the City the road/utility improvements to the site, and build a new elementary school the size of Tafoya. Our children are scattered throughout the District, to private schools, and Davis Joint Unified School District. Lets fight for Woodland children to have neighborhood schools with class mates that live down the street and the ability to walk and bike to school. It was the Woodland way.

Hola superintendente Ortega-Lampkin, presidente Villagrana y miembros de la junta,

Mi nombre es Brian Coward. Soy padre, esposo, residente de Woodland y miembro del groupo Woodland Accountablility Community. Estoy aquí una vez más para llamar la atención de mi Distrito y la Junta Directiva sobre la terrible inequidad que se impone a los Woodlanders y la suma de 880 niños de Spring Lake que no tienen acceso a una escuela del vecindario. Este Distrito hizo un acuerdo con los residentes de Woodland y los desarrolladores de Spring Lake (Turn Of the Century, TOC) para proporcionar dos escuelas, cada una con una capacidad de 650 estudiantes, y por una tarifa que cada residente pagó, en promedio, \$16,000. Spring Lake está casi completo. Tenemos una sola escuela, Spring Lake Elementary, con una capacidad de 420 estudiantes anémicos.

Punto N. Información: Las solicitudes de futuros puntos de la agenda incluyen un 'TBD: Expansión potencial de la escuela primaria Spring Lake (solicitada a través de la acción de la Junta)'. Síndico Rodríguez, usted inició esta solicitud en la última reunión de la junta. Creo que tenía buenas intenciones, pero como sabe, el Distrito y la Junta trabajaron en tal esfuerzo en octubre de 2021 y fracasó debido a la abrumadora desaprobación del público. Hay desafíos con el salón de usos múltiples, el centro de estudiantes, las áreas asfaltadas, la seguridad y la seguridad vial existentes que no fueron diseñados para acomodar un campus más grande o más estudiantes. Expandir el campus de la Escuela Primaria Spring Lake no es el mejor uso de nuestros recursos y resultará en que menos estudiantes tengan acceso a las escuelas del vecindario.

Fideicomisario Rodríguez, solicite que se elimine este elemento de la lista de elementos de la agenda futura y siga esa solicitud con una para discutir la modificación de la Evaluación de Instalaciones del Distrito (DFA) para incluir una nueva escuela primaria en el Parque de Investigación y Tecnología. Necesitamos que se modifique la DFA lo antes posible, ya que la Ciudad está finalizando los planes para que comience el desarrollo y que, cuando esté completo, agregará 4,000 Woodlanders adicionales. Enmendar el DFA es el primer paso para asegurarnos de que podamos planificar, financiar, comprar terrenos, coordinar con la Ciudad las mejoras de carreteras/servicios públicos en el sitio y construir una nueva escuela primaria del tamaño de Tafoya. Nuestros niños están dispersos por todo el Distrito, en escuelas privadas y en el Distrito Escolar Unificado Conjunto de Davis. Luchemos para que

los niños de Woodland tengan escuelas de vecindario con compañeros de clase que vivan al final de la calle y la capacidad de caminar y andar en bicicleta a la escuela. Era el estilo Woodland.

#### Thank You

First, thank you staff and trustees for working together to use and publicize metrics on effective teaching and learning practices.

## **Strongly Support Teacher Collective Efficacy**

We strongly support efforts to improve teacher collective efficacy because it is the single most important quality leading to improved student outcomes. John Hattie, internationally renowned education researcher has shown it has an effect size of SDS = 1.57 (updated in 2018). Within WJUSD, we understand this would be called (in whole or in part) data-driven collaborative professional learning communities (PLCs).

We acknowledge that our comments/questions are limited to just the documents provided by the Board Agenda. Also, we presume these SPSAs were approved by the various School Site Councils.

## Questions

1. In the board meeting on April 27, 2023 a staff member made a comment that WJUSD doesn't presently measure the implementation of PLCs. We also know that some teachers last year created their own staff surveys because none were provided to them. What would it take to immediately begin using reasonably trusted, third-party rubrics or surveys to measure PLCs (teacher collective efficacy)?

- 2. Teachers and those that support their effectiveness are the most important contributors to WJUSD's student outcomes. However, in the footnote below is a count of the measures included in each proposed SPSAs; no teacher, staff, or teaching related measures have been included in the SPSAs. What would it take to include 1 to 3 of the most important aggregate measures related to teaching in each school's SPSA?
- 3. Other than student outcomes, what has WJUSD used to measure teaching this year?

For example, how many months does it take for teachers to become proficient or exemplary in the most

effective teaching practices? As a comparison, Uncommon Schools has goals at 30 days, 90 days, and 1 year. Their goal is for teachers to become proficient in all key practices before the end of a teacher's first year.
