Public Comments Submitted Via Email

Dear Board Members,

I am a member of W.A.C. and a local attorney. I reside on the South side of the Spring Lake development and have been personally involved in WAY too many school development issues since we moved here in 2013.

I was heavily involved in getting Spring Lake Elementary built THREE ADMINISTRATIONS AGO. Yet here we are again having the same issues of non-representation, improper money management, lack of transparency and a failure of action by the district and even more disheartening, this current board of Trustees.

My comments are as follows:

1. I am a member of W.A.C. and support and understand their frustration with the district and our current board of representatives not getting the job done. We are not a mere 'couple of people' to be disregarded the way we have been so far. By ignoring us you only hurt the children who need safe, accessible schools on an entire side (East side) of your city, Woodland.

- 2. The schools over here on the entire East Side of Woodland are at capacity and the district and the board know it. We continue to be the side of the city where residential development is pushed to generate builder fees and higher property tax income to the city of Woodland, but where basic infrastructure such as accessible schools, is not prioritized at all.
- 3. The district staff has legal counsel, not the board. The district is represented and hiding behind their legal counsel, not the board. The board needs to understand that the district staff are hiding behind legal counsel at this point, but that the board is NOT represented by the same legal counsel. That would be a conflict of interest.
- 4. The district needs to create an environment where kids can attend their assigned school independently. This recent campaign of the district of 'attendance matters' is in complete contradiction to how the board and school district are approaching lack of capacity issues.
- **You have decided to give in to the status quo instead of ensuring schools are where the children need them to be.
- **You are calling for young children to somehow get themselves to schools on the other side of the city from where their home is. These are young, young children. How do you expect to have healthy engagement and attendance when you are not setting up an environment where kids can independently and safely get to their assigned school? Where are the public resources to ensure they can get from the East side of Woodland all the way to central or far West Woodland sites? Your current strategy makes no sense and only hurts families and children that you took an oath to serve.
- 5. Our representative, Trustee Villagrana, is failing to meet his standard of care in representing the constituents of his own area. He will not respond to emails, he will not come out to meet us to discuss our needs and he fails at every turn to do his job on our behalf. The board's main job is to ensure that the voices of its constituents are heard, listened to, engaged with, and met. This board is continuously failing to represent the entire East side of this City's school needs. Rogelio, if you are not up to doing your job as our representative then step down so that we can have a special election to get the right person into your seat.

Conclusion:

I truly hope you all as a board come together, address these issues head on, engage your constituents and stop hiding behind the status quo. In the spirit of celebrating black history month and the amazingly FAR more ridiculously difficult problems black people in America have had to face and continue to face and achieve compared to what this board needs to get done I will end with this quote:

"Impossible is just a big word thrown around by small men who find it easier to live in the world they've been given than to explore the power they have to change it. Impossible is not a fact. It's an opinion. Impossible is not a declaration. It's a dare. Impossible is potential. Impossible is temporary. Impossible is nothing." —Muhammad Ali

We truly do want to partner with the board to achieve what needs to be in order to bring success and accessibility to the children on the over-impacted Eastern side of Woodland, my hope is this board will do the same.

Dear Trustees,

I am a resident of Woodland, live in the Springlake Neighborhood, and am part of the Woodland

Accountability Council (WAC). I purchased my house in 2010 when my son was a year old. The builder promised me that when my son was of age to attend school that the Springlake School would be completed, and my son could walk to school. Obviously, that was a lie.

By the time my son was ready to start school, the Springlake School was not constructed, and Tafoya was at maximum capacity. Although at capacity, I was offered to have my son attend Tafoya or another school in another district. As a single mother, who has always worked in Sacramento, I had no options for him to get to and from these schools. I became so discouraged with the Woodland School District, that I went ahead and enrolled my son into Woodland Christian School. As a single parent my funds are limited; however, I was fortunate enough to be approved for financial aid to assist with his tuition and help with transportation. I should have never felt that private school was the only option for my son.

I continue to be frustrated with the district, as houses are being built at a rapid rate, including high density housing, without a plan for another neighborhood school. What happens to other single mothers like me who are struggling to make ends meet or with limited resources (such as no local family to help) only to be told that their child must attend school across town because Springlake Elementary is past capacity? Does the district care that working parents must make their young children walk to Tafoya, which includes crossing major roads (Pioneer and Gibson)? This is absurd! The district continues to mention that this is all "equitable", however I cannot understand how this is equitable for the children in our neighborhood.

Again, I am frustrated that you continue to ignore the issue and take no action to remedy this problem. I encourage the district to do better for our children.

Hello,

I'm submitting this public comment on a petition supporting neighborhood schools. I'm submitting this for your review and record. I will be attending the Board meeting tonight to present my comments.

Hello Superintendent Ortega-Lampkin, President Villagrana, and Board Members,

My name is Brian Coward. I'm a father, husband, and Woodland resident and I'm here for several items on tonights agenda but this public comment is for 'Item F. - Public Comment'. I came to this Board back in 2019 with petition signatures supporting neighborhood schools (see attached). At the time I was greeted with reassurances and gratitude by Board members for bringing up an important topic. I'm here once again providing 315 signatures, comments, and supporting documentation for neighborhood schools. Each signature sends an email to Trustee Villagrana and Council Member Vega.

I was told back then that a very long process of updating the "Facility Master Plan" was necessary to determine whether new elementary schools were needed. I was stunned to discover the recently approved "District Facilities Assessment" (DFA) was explicitly done without enrollment projections (Powerschool - see attached) in Woodland, that using existing elementary school capacity was satisfactory, and that no new schools would be necessary. These findings are completely counter to the expressed gratitude by some of you on this Board when presented with the petition back in 2019. It's completely counter to all the evidence of a growing population that pays fees and taxes to build schools. Yet the Board approved the assessment. This outcome further diminishes the expectations of the community for a new school and is detrimental to negotiating a favorable developer agreement with the Tech Park.

I requested an item agenda (Board Meeting - Oct. 27.) to amend the DFA with the PowerSchool

projections which show declining elementary school enrollment west of HWY113 and overenrollment east of HWY113. The intent of the request was to also include adding a new school to the DFA so the District could pursue financing, planning, and building one. The Superintendent suggested this type of amendment would require starting the assessment over. This is false as Board Policy 7110-8: Facilities Master Plan states there is a process for; "reviewing and updating the plan."

In order for the District to provide neighborhood schools for Woodlanders we must have the DFA amended to show the District is pursuing a new school. I would also like the Board to hold Administrative Staff accountable for wasting resources, mis-management of funds, and lying to you and the public about matters that so drastically affect our children. We need pubic servents that are honest and capable.


Attention: Woodland Joint Unified School District.



Plan Development

The district's facilities master plan shall be based on an assessment of the condition and adequacy of existing facilities, a projection of future enrollments, and alignmen program.

To solicit broad input into the planning process, the Superintendent or designee may establish a facilities advisory committee consisting of staff, parents/guardians, and representatives. He/she also shall ensure that the public is informed of the need for construction and modernization of facilities and of the district's plans for facilities.

At least 45 days prior to completion of any facilities plan that relates to the potential expansion of existing school sites or the necessity to acquire additional school site of the plan or any relevant and available information to the planning commission or agency of the city or county with land use jurisdiction within the district. (Government)

If the city or county commission or agency requests a meeting, the Superintendent or designee shall meet with the commission or agency within 15 days following the I include, but are not limited to, methods of coordinating planning with proposed revitalization efforts and recreation and park programs, options for new school sites, m the site, and opportunities for financial assistance. (Government Code 65352.2)

The master plan shall be regularly reviewed and updated as necessary to reflect changes in the educational program, existing facilities, finances, or demographic data.

Plan Components

The facilities master plan shall include:

- 1. A statement of purpose, including district goals, philosophy, and related policies
- 2. A description of the planning process
- 3. Demographics of the community, such as economic trends, migration patterns, employment base, residential base, socioeconomic makeup, historical school enro
- 4. A description of the educational program, such as grade-level organization, class size, staffing patterns, technology plans, special programs and support services,
- 5. Analysis of the safety, adequacy, and equity of existing facilities and potential for expansion, including the adequacy of classrooms, school cafeterias and food pre areas, and other school grounds
- Site selection criteria and process
- 7. Development of a capital planning budget and identification of potential funding sources
- 8. Policy for reviewing and updating the plan


Planning shall ensure that school facilities meet the following minimum standards: (5 CCR 14001)

- 1. Are aligned with the district's educational goals and objectives
- 2. Provide for maximum site enrollment at school facilities
- 3. Are located on a site that meets California Department of Education standards as specified in 5 CCR 14010
- 4. Are designed for the environmental comfort and work efficiency of the occupants
- 5. Are designed to require a practical minimum of maintenance
- 6. Are designed to meet federal, state, and local statutory requirements for structure, fire, and public safety
- 7. Are designed and engineered with flexibility to accommodate future needs

Plans for the design and construction of new school facilities also shall meet the standards described in 5 CCR 14030, green building standards pursuant to 24 CCR 10 12101-12213, and any other requirements applicable to the funding source and type of project.

To facilitate the efficient use of public resources when planning for new construction or modernization of school facilities, the district may consider designs that facilitie public postsecondary institution, or nonprofit organization.

Problem

There have been multiple amendments made to the Spring Lake Specific Plan which have eliminated key components of neighborhood access to schools for our children. As a community, we have invested heavily in our infrastructure to provide safe access through our greenbelts to neighborhood schools, parks, and commerce. With two of three planned school sites covered in homes, a new Research and Technology Park Specific Plan (draft) lacking zoning for a school(s), and District fee justification studies showing a projected elementary-age population of 1,400, we find our community at risk of losing the opportunity to have enough neighborhood schools.
