Public Comments Submitted Via Email

Hello Superintendent Ortega-Lampkin, President Villagrana, and Board Members,

My name is Brian Coward. I'm a Woodland resident and member of the Woodland Accountability Community group. Our community brought a petition, four years ago, which showed the need for new schools where Woodland was growing and based upon the Districts own fee studies. We were told that a lengthy process of updating our facility master plan was necessary. That 'Districtwide Facilities Assessment' (DFA) was approved, by this board, without a new school in the plan. Trustee Villagrana, prior to approval of that assessment, you clarified with the consultant that there was no need for new schools and that existing elementary schools had capacity due to declining enrollment. You later voted yes on the DFA, ignoring your constituents' concerns.

There are many neighbors in our group who placed their faith in the District and Board that the professed need for a facility master plan update was necessary. I've come to realize those were empty words. The true vision of this District and Board have been revealed in the DFA. Woodlanders and the tradition of providing neighborhood schools for their children will be abandoned. Community, abandoned. Children's ability to walk or bike to school together, abandoned. Neighborhood Elementary schools which serve as critical community infrastructure, abandoned.

Trustee Villagrana, you represent Area 7 which includes Spring Lake. A trustee's responsibilities according to the California School Board Association are:

- setting direction
- establishing an effective and efficient structure, providing support
- ensuring accountability
- providing community leadership as advocates for children, the school district and public Schools

You have failed at every turn to advocate for the children in your area. At the last board meeting you stated; "I represent — I was elected from the seventh area but I represent all students in the district and the seventh area is a very big area." You felt the need to diminish your responsibility, openly, to represent the needs of area 7 children by stating you "represent all students". Your failures should necessitate your resignation, but since you haven't, I've been consulting with Yolo County Election Office officials who, unlike this District, have been very helpful in my inquiry into your recall. In that pursuit, I've discovered that it is only registered voters from area 7 that can recall you. So, as an elected representative, remember the constituents that you serve and your responsibilities according to your peers.

Finally, I prescribe to the proverb that 'Where there is a will, there is a way.' I ask this Board if it's not your will to amend the DFA to include a new school, hold District staff accountable for mismanagement and non-compliance with government code, to make a plan on how to achieve the necessary financing/land acquisition/construction of a new school where Woodland is growing you need to get out of the way.

Hola superintendente Ortega-Lampkin, presidente Villagrana y miembros de la junta,

Mi nombre es Brian Cobarde. Soy residente de Woodland y miembro del grupo Woodland Accountability Community. Nuestra comunidad presentó una petición, hace cuatro años, que mostraba la necesidad de nuevas escuelas donde Woodland estaba creciendo y en base a los propios estudios de tarifas del distrito. Nos dijeron que era necesario un largo proceso de actualización del plan maestro de nuestras instalaciones. Esa 'Evaluación de las instalaciones de todo el distrito' (DFA) fue aprobada por esta junta sin una nueva escuela en el plan. Síndico Villagrana, antes de la aprobación de esa evaluación, usted aclaró con el consultor que no había necesidad de nuevas escuelas y que las escuelas primarias existentes tenían capacidad debido a la disminución de la inscripción. Más tarde votó sí a la DFA, ignorando las preocupaciones de sus electores.

Hay muchos vecinos en nuestro grupo que pusieron su fe en el Distrito y la Junta de que la necesidad declarada de actualizar el plan maestro de las instalaciones era necesaria. Me he dado cuenta de que esas eran palabras vacías. La verdadera visión de este Distrito y Junta ha sido revelada en el DFA. Woodlanders y la tradición de proporcionar escuelas de vecindario para sus hijos serán abandonadas. Comunidad, abandonada. La capacidad de los niños para caminar o ir en bicicleta a la escuela juntos, abandonada. Escuelas primarias vecinales que sirven como infraestructura comunitaria crítica, abandonadas.

Síndico Villagrana, usted representa el Área 7 que incluye Spring Lake. Las responsabilidades de un fideicomisario según la Asociación de Juntas Escolares de California son:

- dirección de ajuste
- establecer una estructura eficaz y eficiente, proporcionando apoyo
- asegurando la rendición de cuentas
- proporcionar liderazgo comunitario como defensores de los niños, el distrito escolar y las escuelas públicas

Ha fallado en todo momento en abogar por los niños en su área. En la última reunión de la junta usted declaró; "Represento: fui elegido de la séptima área, pero represento a todos los estudiantes del distrito y la séptima área es un área muy grande". Sintió la necesidad de disminuir su responsabilidad, abiertamente, de representar las necesidades de los niños del área 7 al afirmar que "representa a todos los estudiantes". Sus fallas deberían requerir su renuncia, pero como no lo ha hecho, he estado consultando con los funcionarios de la Oficina de Elecciones del Condado de Yolo quienes, a diferencia de este Distrito, han sido de gran ayuda en mi investigación sobre su destitución. En esa búsqueda, descubrí que solo los votantes registrados del área 7 pueden recordarlo. Entonces, como representante electo, recuerde los electores a los que sirve y sous responsabilidades de acuerdo con sus pares. Finalmente, prescribo la expresión 'Donde hay una voluntad, hay un camino'. Le pregunto a esta Junta si no es su voluntad enmendar el DFA para incluir una nueva escuela, responsabilizar al personal del Distrito por la mala administración y el incumplimiento de código del gobierno, para hacer un plan sobre cómo lograr el financiamiento necesario/adquisición de terreno/construcción de una nueva escuela donde Woodland está creciendo, necesita salir del camino.
