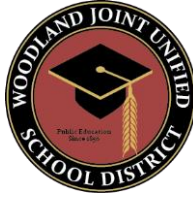

The Woodland Joint Unified School District is seeking qualified, interested individuals to serve on the Budget Advisory Committee (BAC). The general purpose of the BAC is to make recommendations during the budget development process and its duties shall be assigned each year based on district needs. All recommendations of the BAC shall be advisory only and shall not be binding to the Board.

Committee Responsibilities and Membership

The BAC's duties may include, but not necessarily be limited to:

- Making recommendations regarding budget priorities
- Recommending cost reduction strategies, such as identifying services that may be reduced, made more efficient, or discontinued
- Reviewing the clarity and effectiveness of budget documents and communications
- Presenting progress reports on the committee's work and a final report of recommendations to the Superintendent or designee and to the Board

Committee Members and Term

The Superintendent or designee may appoint a budget advisory committee composed of staff, Board representatives, and/or members of the community. There can be up to 20 total members. Members generally serve a one-year term.
