Update on Phase 3 Reopening

- On February 18, the Board voted to bring back a resolution that would establish a Phase 3 reopening date of April 12
- On February 25, the Board voted to approve the April 12 reopening date
- April 12: first day of Phase 3
 - Preparations
 - District-wide training on March 24 on health and safety protocols
 - Parents are being notified of schedules and group placement
 - Orientations/meetings being held this week
- Phase 4 Reopening: the Board approved on March 25, the first day of school (August 16, 2021) as the beginning of Phase 4 (in-person learning with restrictions) consistent with Yolo County and CDPH guidelines
