


## Instructional Program Options for 2020-2021

- Phased In Approach (Includes Remote Learning)
  - Virtual Academy

#### What is Remote Learning?

- Remote learning is a response to school closures, to maintain continuity of teaching and learning.
- Students and teachers remain in their regular class configuration, but learning is facilitated through an online platform while students are at home.
- As schools are able to reopen, in-person instruction is phased in.



#### Remote Learning - Instructional Program

- All students receive instruction remotely
- Teachers and related service providers have the resources they need to provide effective remote learning
- Expectations include:
  - minimum instructional minutes with whole and small group instruction
  - synchronous and asynchronous instruction
  - office hours
  - frequent communication with students/parents
  - teacher team prep/planning
  - all students receive tiered support as needed

# What is the Virtual Academy?

A new instructional program option for families who want to opt in to online learning for the entire school year.



## Why Develop a Virtual Academy?

- Provides an option for parents who prefer not to send their student to a physical school setting, are concerned about potential changes during the school year due to health and government guidelines, and/or their student thrives in a virtual/distance setting
- Reduces amount of students physically on school campuses
- May address the need of students and staff in the high risk groups
- Sets a foundation to continue and expand virtual learning in the district for future years
- Builds on already existing programs: (K-8) Home Study and (9<sup>th</sup>-12<sup>th</sup>)
   Independent Learning Center (ILC)

#### Virtual Learning - Instructional Program

- online (delivered through Canvas) and print-based coursework
- elementary and middle school
  - core curriculum is the foundation
  - coursework will be developed collaboratively by teachers
- high school
  - A-G certified (provided through UC Scout, CyberHigh, and teacher created)
  - limited course options initially with the potential to add courses as the program grows
- students have increased flexibility to work at their own pace
- training and support for parents
- Preschool and Dual Immersion program options will be developed depending on enrollment

What do remote learning and a Virtual Academy have in common?

#### STANDARDS-BASED INSTRUCTION IN AN ONLINE SETTING

Teachers will use the curriculum standards to guide and plan their instruction.

## COLLABORATION IS INTERACTIVE BETWEEN STUDENTS AND TEACHERS

Students and teachers have regular, planned opportunities for interaction. Students collaborate with their teacher and with each other.

#### STRUCTURES AND ROUTINES

Learning opportunities are intentionally planned to support students, with some flexibility to account for varied family situations.

#### ONE LEARNING PLATFORM

Canvas will be the learning management system that will serve as a hub for course material.

## COMMUNICATION AND FEEDBACK ARE ESSENTIAL

Students and parents will receive feedback on student progress. The Canvas parent app will provide visibility for parents, as well as serve as a hub for parent training.

#### **TEACHER TRAINING**

Teachers will receive training in online pedagogy, curriculum and standards, "how to" for Canvas and technology tools, engagement strategies, and supporting parents.
