## School Facility Conditions and Planned Improvements

Beamer Park Elementary School, originally constructed in the 1930s, offers a safe and secure campus for students, staff, and visitors. The school is currently comprised of 22 classrooms, including portables, one library, one multi-purpose room, one staff room, and three playgrounds. A beautiful mural was painted on the side of the building to represent Beamer's students and the focus on multicultural/multilingual education. Facility information is current as of November 8, 2021.

### Cleaning Process

The Principal works daily with the custodial staff to ensure regular and continual maintenance of the school's physical environment.

### Maintenance and Repair

District maintenance staff ensure that the repairs necessary to keep the school in good repair and work orders are completed in a timely manner. A work order process is used to ensure efficient service and highest priority to emergency repairs. At time of publication 100% of restrooms on campus were in working order.

## B. Pupil Outcomes

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. #### 2021-22 Opportunities for Parental Involvement

The school district benefits from extensive support from parents and community members. Beamer Park Elementary School is proud of its many opportunities for parents to volunteer their time. These opportunities include classroom and project volunteers, field trip chaperones, fund raising, English Learner Advisory Committee (ELAC), Parent Teacher Association (PTA), monthly coffee with the principal and School Site Council (SSC) membership. Parents are also encouraged to participate in community forums at the district level and are able to attend Community and Family Engagement (CAFE). Input is valued from parents, staff and students and is collected via surveys and meetings with various groups. Surveys were distributed in every classroom to share with parents, along with making them available on Parent Square for all stakeholders to complete such as SSC, PTA and ELAC. A student advisory council meets with site administration and site leaders through out the year to provide feedback and be inclusion of student voice in decisions made on campus. Student voice is gathered through surveys and our student advisory council, which makes recommendations for the School Plan for Student Achievement, as well as the school safety plan.

Beamer Park Elementary School also benefits from partnerships with Walmart, Save the Redwoods League, Migrant Education, Yolo Farm to Fork, Mondavi Center, Yolo Arts Council and partnered with United Way.

## 2021-22 School Safety Plan

The safety of students is a priority of the school staff. Students are supervised throughout the day by teachers, administrators, and noon duty aides. There are several designated areas for student drop-off and pick-up at the school. Visitors to the school must check in and out at the office.

Beamer Park Elementary School's Site Safety Plan is revised yearly by the School Site Council, which consists of administrators, teachers, counselors, classified staff, and parents. A student survey was also sent out to seek student input for the school's safety plan, from students in grades 3-6. As we were looking to be inclusive of student representation and voice in reviewing areas of success and improvement. A parent survey is also distributed to our stakeholders to seek input from our parents, ELAC, PTA and SSC. We encouraged our families to complete the survey which was shared school wide in classroom links, as well as Parent Square, digitally for all families and participation was encouraged. Key elements of the Safety Plan include student safety, school climate, and emergency procedures.

The school is in compliance with all laws, rules, and regulations pertaining to hazardous materials and State earthquake standards. Emergency drills are conducted on a regular basis throughout the school year, including monthly fire evacuations and biannual disaster and intruder drills. In the event of an emergency, the school's Disaster Preparedness Plan has clearly defined procedures to accommodate crisis situations, and emergency supplies are available. The safety plan was last approved in September 2021. The safety plan was reviewed with staff, parents and students at the beginning of the 2021-22 school year and is revisited as necessary.

## Professional Development

Woodland Joint Unified School District provides time and resources for collaboration, planning, and professional development for all staff. Teachers at each school receive training directly related to curriculum and instruction by attending workshops and conferences that are approved by the district and administration. Staff development days enable staff members to deliver curriculum and instruction that is rigorous, challenging, and responsive to student needs.
