2021-22 School Overview

The culture of Whitehead Elementary School reflects a strong belief that all learners will achieve at a high level and be academically successful with the support of an effective program that includes distance learning. In addition, staff are implementing SEL (Social Emotional Learning) programs on a regular basis to support the Social Emotional Learning needs of our learners during the Covid-19 pandemic and beyond. Ongoing efforts are made to maintain a school wide focus on a high-level standards-based education. Continuous improvement and Growth Mindset are central to the culture of the school. Students are recognized for citizenship, responsibility, academic achievement, attendance and Character Traits. Whitehead Elementary is in the process of developing a new STEM (Science, Technology, Engineering and Math) program to be implemented at all grades TK-6th. The Whitehead Elementary staff, teachers, parents, students, ELAC (English Learner Advisory Committee) and Booster Club will continue to communicate clearly and work effectively to enable our students to meet standards and to achieve our school wide site plan goals and objectives.

Our mission is for every student attending Whitehead Elementary School to have the requisite skills needed to be successful in middle school and high school; and ultimately college, career, and life. The school operates on a traditional calendar. Whitehead has 347 students enrolled in transitional kindergarten through sixth-grade in 2020-2021.

Woodland is located in Yolo County and has a rich heritage of community spirit and neighborly charm. With a population of more than 56,000 people, the town is situated twenty miles from downtown Sacramento and 85 miles from San Francisco. Woodland Joint Unified School District includes seven preschools, eleven elementary schools, one charter elementary school, two middle schools, two comprehensive senior high schools, a continuation high school, and an adult school, and served approximately 9,658 students in the 2020-21 school year.

Whitehead Elementary School is proud of its many opportunities for parents to participate in their student's education. Typically these opportunities include classroom and project volunteers, field trip chaperones, fundraising, English Learner Advisory Committee (ELAC), Booster Club, and School Site Council (SSC). During distance learning, parent involvement is primarily through ELAC, School Site Council and the Booster Club. The Booster Club requires no membership dues, with the goal of increasing parent participation. Virtual Parent/Teacher conferences are attended at a high rate. Whitehead values parent involvement, and welcomes parents as part of our learning community. The Student Leadership Team, comprised of two students from each 5th and 6th grade classroom, meet bi-weekly. In addition, the Student Advisory council meets with the principal five times per year to ensure that students' voices are heard, data is reviewed and recommendations are shared with the School Site Council.

During the Covid crisis, we are working hard to support parent participation at Whitehead. The staff and school are utilizing Parent Square to communicate with families. The administration and office staff ensure that communications to parents are made by text, post, email and all calls on a weekly basis. Interpreters are provided for our Spanish speaking parents for meetings as needed.

2021-22 School Safety Plan

Whitehead Elementary School's Comprehensive School Safety Plan is revised annually by the School Site Council, which consists of administrators, teachers, classified staff, and parents/community members. The 2020-2021 Comprehensive School Safety Plan was approved by the Whitehead Site Safety Committee in September 2021. Key elements of the Comprehensive School Safety Plan include student safety, conflict resolution strategies, and emergency preparedness. Students are supervised throughout the day by teachers, the principal and certified noon duty supervisors. There is a designated area for student drop-off and pick-up at the school. Visitors to the school must check in at the office and wear a visitor's badge while on campus.

The school is in compliance with all laws, rules, and regulations pertaining to hazardous materials and State earthquake standards. All safety drills continue to be held on campus. Emergency drills are conducted on a regular basis throughout the school year, including monthly fire evacuations, quarterly earthquake drills and quarterly lockdown drills. In the event of an emergency, the school's Disaster Preparedness Plan has clearly defined procedures to accommodate crisis situations, and emergency supplies are available.

Professional Development

Woodland Joint Unified School District provides time and resources for collaboration, planning, and professional development for all staff. Teachers at each school receive training directly related to curriculum and instruction by attending workshops and conferences that are approved by the district and administration. Staff development days enable staff members to deliver curriculum and instruction that is rigorous, challenging, and responsive to student needs. The development of a common district-wide instructional focus is allowing entry point for everyone to learn and stretch their practice. The focus of professional development has shifted to provide job-embedded coaching across multiple content areas to build capacity and focus on strengthening application of instructional strategies.

Woodland Joint Unified School District uses a variety of professional learning models to engage staff in their continued growth. During the school year and summer, staff have opportunities to complete professional development learning episodes and time to implement best practices learned.
