WJUSD and Teacher Negotiations Update – June 3, 2022

DISTRICT AND TEACHERS' UNION REACH TENTATIVE AGREEMENT FOR NEW COLLECTIVE BARGAINING AGREEMENT INCLUDING 10% ONGOING SALARY INCREASES OVER 2 YEARS, AND INCREASED BENEFIT CONTRIBUTIONS

The District and WEA have reached a Tentative Agreement settling successor negotiations for a new three-year contract term through June 30, 2025. This agreement settles salary and benefits years and includes the following:

- 6% Salary Increase for 2022-2023
- 4% Salary Increase for 2023-2024
- \$3,000 one-time payment (based on an employee's hours per day) payable 90-days after agreement is Board approved
- \$1,000 one-time payment (based on an employee's hours per day) payable by September 30, 2024
- Employee benefits contribution increased to **\$9,360** annual for Employee only-medical coverage and **\$11,400** annually for Employee +1 or Family medical coverage.
- Five (5) Professional Development Days in 2022-2023
- Five (5) Professional Development Days in 2023-2024
- 30 hours of additional planning, preparation and collaboration time for Dual Immersion, combination class and special education teachers in the 2022-2023 school year
- 1-year extensions for increased pay rates for secondary teachers who substitute during their prep and for elementary E.L. Specialists that substitute in a classroom.
- 1-year extension for payments to elementary teachers who may miss their prep due to the unavailability of a release teacher.

The WEA negotiations team will meet with their members to support ratification of the agreement and follow up with a vote per their bylaws. After ratification by WEA, the Tentative Agreement will be presented to the Board of Trustees for approval on June 30, 2022.

It has been a challenging year and both teams worked extremely hard to develop a new contract and to reach this agreement. We appreciate the efforts of all involved.
